Will Southwest Airlines Survive?, by Frank M. Jay

On August 15th, 2022 we published an article entitled "Airline Merger Merry-Go-Round" as part of our monthly newsletter. That article stated that the potential JetBlue acquisition of Spirit Airlines could indicate the beginning of airline mergers...in all segments of the market...once again.

Our article proposed that even the largest airlines...considered to be "major airlines...could be reduced from four (United Airlines, Delta Airlines, American Airlines, and Southwest Airlines) down to three...and then to two...within a decade.

Although at the time we didn't include our thoughts in that article, we believed that Southwest Airlines would survive to be one of the "three" major carriers, and then time would tell how things would go from there.

Now, one year later, we question whether Southwest might be the first current "major" airline to succumb to an acquisition process.

Our thinking, based on what we read and what we know of the U.S. aviation industry, is that Southwest has become an airline without a niche. We believe that, with the development of the "ultra low cost carrier" industry segment, that the airline industry has expanded to the point that Southwest's part of the market has been left behind...that there is no need for an airline of Southwest's size that is stuck between the ULCC segment and the Major airline segment...and that Southwest potentially faces reduced passengers and revenue.

We certainly could be wrong. Or, the airline could change its direction and become a "different" type of airline completely. It could do so in a number of different ways. It could "rebrand" and become an ULCC airline and compete with Allegiant, Frontier, etc. Or, it could be the acquirer of another major airline (American, United, or Delta) which again would change Southwest's direction in the industry.

The point is that we believe that Southwest currently faces a "market" issue...and that has not been their case since the company was founded on the basis of "lower fares", low costs, exceptional service, and heavy capacity to key airports. They no longer provide the lowest fares. They now serve domestic locations throughout the U.S. and they provide service that is no longer dramatically better than their major airline competitors. In our opinion, the first point (low fares) and the last point (better service) are the "telling" ones.

What their "next step" will be remains to be seen.
